This was mentioned at the last meeting and the Clerk had made enquiries to be advised that it was not customary for parish councils to be consulted on applications for a premises licence. The licence is to cover one weekend in May annually as well as occasional one-off smaller events. Police matters have been agreed and any comments were to be received by 6 August 2019.

- 9 Public Sector Bodies (Website and Mobile Applications) (No 2) Accessibility Regulations 2018
- a) To consider preparation of an accessibility statement for the purpose of making the content as accessible as possible by explaining what the website provides for those who are interested. The Clerk said that he would attempt to create an accessibility statement for adoption by the Council in due course. Although the 2018 Regulations are now in force, the new duties will not apply to websites in existence prior to 23 Sept 2018, until 23 Sept 2020. For websites created on or since 23 Sept 2018, the deadline is 23 Sept 2019. The Clerk commented that perhaps it was time for the Council to again consider creating its own website, and the Chairman referred to websites operated by neighbouring parish councils, It was decided to include this matter on the next agenda,
