76/22. Code of conduct - localism Act 2011

77/22. Councillor Co-option. Ongoing.

Council resolved to approve the minutes.

79/22. Matters Arising & Actions.

Ref 64/22 – Emergency Planning support telephone numbers are displayed on the website and both notice boards, the numbers may be used to enable emergency support following storm/ flooding incidents and involving long term power outages.

66/22 – The overgrown vegetation from the YDNP car park has now been trimmed by the parks resulting in safer driving conditions at the B6479 junction. Allotment branches also trimmed.

68/22 – The Clerk informed Council that Craven District Council had so far not issued an invoice for the waste bin at Stainforth Foss, reports received reflected that the litter situation had much improved following the installation of the bin.

The Clerk informed Council that notification had been received from NYCC that the price for electricity had risen approximately 98% and this increase would be reflected in the next invoice to Council. **Action** – Clerk to liaise with ENWL for a disconnection quotation.

The Chairman welcomed Cllr Staveley to the meeting. Effective wi-fi in Stainforth was discussed by Council with Cllr Staveley highlighting the B4RN system which had been installed nearby in the new industrial site at the Hoffman Kiln. The Clerk informed Council that village halls may be able to have broadband installed for free, Clerk to forward details to Cllr Sharp.
