Councillors present – A. Blackburn (Chairman), A. Sharp, S. Warren, D. Uren. No public present.

36/20. Apologies for Absence. All present.

37/20. Code of conduct - localism Act 2011

38/20. Councillor Co-option.

Councillor position still vacant, Chairman to dedicate more time for recruitment.

39/20. Minutes of the Parish Council meeting held 11th August 2020 – Approved.

40/20. Matters Arising.

Ref 27/20 - The GDPR 1 document has been uploaded to the Council website to be followed with the GDPR 2 document once approved by Council.

28/20 – Cllr Uren had been unable to initiate work on the Little Stainforth notice board due to the weather conditions.

29/20 – Y.D.N.P. walking guides have now been updated to incorporate advice on footwear.

34/20 – Cllr Uren presented residents preferencel in relation to the time clock for the street lamp at Little Stainforth, this being the 5 hour dusk timed clock.

41/20. Public Participation. No public present.

42/20. General Data Protection Regulations – Document 2 (Records management policy) Council resolved to approve the document.

43/20. Litter Situation - ongoing problems.

The Chairman presented an update on the litter situation around the Y.D.N.P. car park and credited CDC staff for the effective removal of waste from the new bin outside the car park, sometimes the bin had been emptied daily during busy periods of the season.

Cllr Uren informed Council that the litter situation had greatly improved at the Foss since the posting of signage aimed at those who would usually drop litter. Council to monitor the situation.

44/20. Y.D.N.P. - Consultation.

Council discussed the latest phase of the consultation and the current dereliction/ state of repair relative to barns, and outbuildings within the area. Council resolved to forward a response to Y.D.N.P. suggesting the authority offer incentives for landowners to renovate these type of buildings.

The Chairman relayed to Council residents concern of the overgrown trees along the beckside from the stepping stones to the car park. He was liaising with Y.D.N.P. and would inform Council of any advice received from the authority.
